Bo's Place exists to enhance the lives of those who have experienced the death of a loved one. Bo's Place specializes in grief support services for children, ages 3 to 18 and their families that have experienced the death of a child or adult in their immediate family.

Bo's Place also offers special programming for children and families enrolled in grief support groups including Parent Night Out, Family Fun Night, Summer Fun, Movie Nights. During the 2015-2016 fiscal year, 688 children and 606 adults participated in Bo's Place grief support groups. Bo's Place clinicians and staff also provided 242 community education and training opportunities throughout the greater Houston area to a variety of audiences including professionals in the social service, medical, educational, and faith-based communities (reaching over 1,787 individuals).
